

## **Agreement to Official Rules**

By participating in the Junkanoo Summer ( JSF) Contest, Entrants agree to abide by the terms and conditions, thereof, as established by Sponsor. Sponsor reserves the right to alter any of these Official Rules at any time and for any reason. All decisions made by Sponsor concerning the Contest shall be final and at its sole discretion.

**Online voting for the Five Man Combo begins on Saturday, August 14<sup>th</sup> 2021 at 7:00 PM EST and will close on Thursday, August 19<sup>th</sup> 2021 at 5:00 PM EST.**

**Online voting for the King Competition begins on Saturday, August 21<sup>st</sup> 2021 at 7:00 PM EST and will close on Thursday, August 26<sup>th</sup> 2021 at 5:00 PM EST.**

**Online voting for the Headpiece Competition begins on Saturday, August 28<sup>th</sup> 2021 at 7:00 PM EST and will close on Thursday, September 2<sup>nd</sup> 2021**

**Winners for each category will be announced the day after voting is concluded, via Facebook.**

**Five Man Combo – Friday, August 20<sup>th</sup> 2021**

**King Competition – Friday, August 27<sup>th</sup> 2021**

**Head Piece Competition – Friday, September 3<sup>rd</sup> 2021**

**Each submission has been prerecorded and will be aired on their specific competition dates.**

### **Five Man Combo Group:**

First place winners are to receive \$1500, Second place winners are to receive \$1000 and Third place winners receive \$500. Winners are based on votes received.

### **King Competition :**

The winner of the King Competition receives \$500. Winning is based on votes received.

### **Best Choreography Category:**

First place winners are to receive \$500, Second place winners are to receive \$300 and third place winners \$200.

### **Intellectual Property:**

By submitting an Entry to the contest(s), Entrant certifies that they are the exclusive rights holder of the Entry. Where necessary, Entrant has acquired all

necessary permissions for use or reuse of any part of the Entry. Entrant shall indemnify and hold harmless, Sponsor for any infringement or other action caused by Entry. Sponsor shall not gain any ownership interest in the Entry. Entrant grants Sponsor an irrevocable, world-wide, royalty free license to use, reproduce, and distribute the Entry in all media whether now known or herein after created.

**Notification of Potential Prize Winners:** The Prize Winners will be notified by e-mail or telephone within 2 (two) days of the selection date. If a Prize Winner does not acknowledge acceptance of the Prize within 2 (two) business days after being notified that he or she is a Prize Winner, another Prize Winner will be chosen using the same procedure specified above.

### **Judging Process:**

- The judging process for the winning contestant will be split via online voting in addition to a judging panel.
- Forty percent of the scoring will be determined by popular vote via the link provided.
- Sixty percent of the scoring will be determined by a panel of judges.
- The final score per contestant will be determined by the weight of these two categories.
- Should there be a tie for each category, voting will reopen for 48 hours only for those entries that are tied.
- If there is still a tie, those entries will be referred to the Chief Judge of the Junkanoo Summer Festival for a final determination.
- The decision of the Chief Judge shall be final
